## What When Where update 2018/19

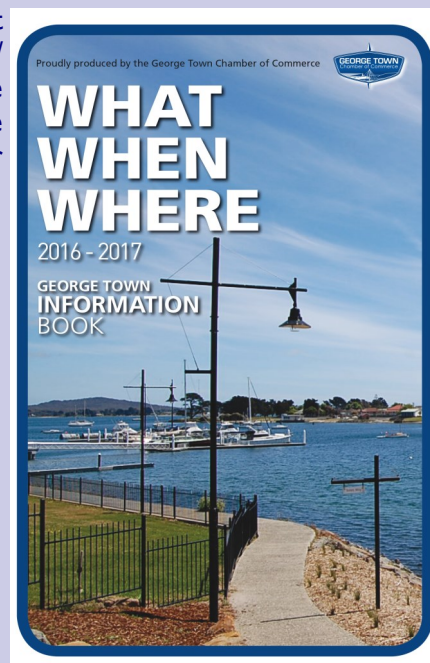
